Regional call for proposal 2023 for attraction of investments in Emilia-Romagna

MAIN OBJECTIVES

- support investments of regional interest that increase the competitiveness and innovative capacity of the regional value chains
- integration with the research and training system
- relevant employment impact (in terms of quality and quantity) and economic, environmental and social sustainability
- the development of the whole regional territory with a focus on specific disadvantaged areas

FINANCIAL RESOURCES

• 13 million euros are available for the present Call for proposals












Regional call for proposal 2023 for attraction of investments in Emilia-Romagna BENEFICIARIES

The call for proposals is open to **enterprises that produce goods and services** and that can be:

- foreign/national companies not already settled in the region that intend to invest in Emilia-Romagna (with at least one local unit to be settled in Emilia-Romagna before the signing of the Agreement)
- regional companies already established in Emilia-Romagna
- newco, made up of at least two subjects with different ownership









Regional call for proposal 2023 for attraction of investments in Emilia-Romagna -• **MINIMUM REQUIREMENTS**

For Micro, Small and Medium enterprises (MSMEs):

- 15 new full-time employees of which at least 30% (minimum 5 people) graduates.
- R&D project minimum amount of 1.5 million euro.
- Collaboration with universities, research institutes/organizations with the following amount: 10% of eligible expenditures up to 1.5 million, 5% of eligible expenditures from 1.5 to 4 million euro, 2.5% of eligible expenditures > 4 million euros.
- An industrial plan has to be attached to the eligible programme.

For Large Companies:

- 20 new full-time employees of which at least 30% (minimum 7 people) graduates.
- R&D project minimum amount of 2.5 million euro.
- Collaboration with universities, research institutes/organizations with the following amount: 10% of eligible expenditures up to 2.5 million, 5% of eligible expenditures from 2.5 to 4 million euro, 2.5% of eligible expenditures > 4 million euros.
- An industrial plan has to be attached to support the eligible programme.







Regional call for proposal 2023 for attraction of investments in Emilia-Romagna -• **TYPES OF INTERVENTION**

The call for proposal allows receiving non-repayable grants - with a single procedure - in the following types of intervention:

- R&D Research and development this type of intervention is mandatory to be eligible for the call
- Research facilities
- Testing and experimentation facilities
- Energy from renewable sources

Only for Micro, Small and Medium enterprises (MSMEs):

• Human resources: hiring of high-skilled employees

Only for companies not already settled in the region before the data of publication of the call:


- **SMEs:** new productive investments related to the industrial, digital and green transition
- Large companies only in assisted areas: new productive investments related to the industrial, digital and green transition

Regional call for proposal 2023 for attraction of investments in Emilia-Romagna - Category of aid: A – DESEADCH EACH ITIES (at a const)

A – RESEARCH FACILITIES (art. 26 GBER)

Only one intervention can be submitted, which can include the following eligible costs:

- a) Systems/installations strictly functional to the research infrastructure activities;
- b) Equipment (cost per each single equipment > 500,000 €)
- c) Software
- d) Patents
- e) Licences
- f) Non-patented know-how and technical knowledge about new technologies
- g) General costs at a flat rate of 5% of total expenditure (a), (b), (c), (d), (e) and (f)

COSTS

ELIGIBLE

- Minimum amount of investment: 1 million €
- Grants up to 50% of the eligible costs
- Maximum amount of aid: 1 million €

Regional call for proposal 2023 for attraction of investments in Emilia-Romagna - Category of aid:

B - RESEARCH & DEVELOPMENT ACTIVITIES (art. 25 GBER)

This type of intervention is mandatory to be eligible for the call

- New research personnel (with open-ended contract, hired after the submission of the application and in a) any case after 1 January 2024)
- Personnel for research, design, experimentation activities (max 30 % of expenditures in points (d), (e), (f)) b)
- Personnel for production functions or research personnel without a degree and less than 10 years C) experience (max 25% of expenditure in the previous point (b))
- Purchase or lease of plant and equipment d)
- Expenses for the acquisition of services with a high content of scientific and technological research (eg: e) patents, technical skills, etc.)
- Physical creation of prototypes (max 20% of expenditures in points (a), (c), (d), (e))
- General costs (max 15% of total expenditure in points (a), (b), (c)) q)

COSTS

ELIGIBLE

- Minimum amount of investment for each project: 2.5 million € for large enterprises, 1.5 million € for MSMEs
- Grants in industrial research: up to 50% of the eligible costs
- Grants in experimental development: up to 25% of the eligible costs
- Maximum amount of aid for R&D activities: 4 million €







Regional call for proposal 2023 for attraction of investments in Emilia-Romagna - Category of aid:

C – TESTING AND EXPERIMENTATION FACILITIES (art. 26bis GBER)

Only one intervention can be submitted, which can include the following eligible costs:

- Systems/installations strictly functional to the testing and experimentation activities; a)
- Equipment b)
- Software C)
- d) Patents
- Licences e)
- General costs at a flat rate of 5% of total expenditure (a), (b), (c), (d), (e)

COSTS

ELIGIBLE

- Minimum amount of investment: 0.5 million €
- Grants up to 25% of the eligible costs
- Maximum amount of aid: 1 million €







Regional call for proposal 2023 for attraction of investments in Emilia-Romagna - Category of aid: **D - ENERGY FROM RENEWABLE SOURCES** (art. 41 GBER)

Only one intervention is possible related to the construction of a plant producing energy for a local unit of the company in Emilia-Romagna.

- Plant (including related works) and equipment dedicated to the specific action and intended to change a) production methods
- General costs at a flat rate of 5% of total expenditure (a) b)

- Minimum amount of investment: 1 million €
- Grants up to 45% of the eligible costs
- Maximum amount of aid: 0.5 million €

E - PRODUCTIVE INVESTMENTS (art. 14 and art. 17 GBER)

a) Expenses for the purchase of tangible and/or intangible assets functional to the technological and digital transformation of companies according to the "Industry 4.0" model as identified in the lists in Annex A and in Annex B of the law n.232 of 11 December 2016 are eligible. The assets must belong to the following identified technologies (identified and described in Annex 2 of the Ministerial Decree of 30 October 2019):

- Advanced manufacturing solutions
- Additive manufacturing
- Augmented reality
- Simulation
- Horizontal and vertical integration
- Internet of things e Industrial internet
- Cloud
- Cybersecurity
- Big data and Analytics
- b) General costs at a flat rate of 5% of total expenditure (a)

Minimum amount of investment: 0.5 million € for MSMEs, 1 million € for Large Companies

Grants:

- Small companies:, up to 20% of eligible costs (assisted area: Ferrara 35% and Piacenza: 30%)
- Medium companies: up to 10% of eligible costs (assisted area*: Ferrara 25% e Piacenza: 20%)
- Large companies only in assisted areas ((census areas of the provinces of Ferrara and Piacenza see call for proposal): eligible costs in assisted areas of Ferrara (up to 15%) and Piacenza (up to 10%)

Maximum amount of aid: 0.5 million €

Regional call for proposal 2023 for attraction of investments in Emilia-Romagna - Category of aid: F - INTERVENTIONS FOR THE ACQUISITION OF SKILLS BY SMES FOR THE INDUSTRIAL, DIGITAL AND GREEN TRANSITION

ONLY FOR SMEs

Gross annual salary costs accrued **in a period of 15 months** deriving from the full-time and permanent employment at local units located in Emilia-Romagna of personnel with a doctorate or equivalent qualification, or with a degree and a previous managerial experience of at least 3 years. The minimum period of 15 months refers to each full-time and permanent employment contract for which the grant is requested, started after the submission of the application to participate in this call and after 1 January 2024.

COSTS

ELIGIBLE

- Minimum amount of the salary costs for each hiring: 90,000 €
- Maximum amount of the salary costs for each hiring: 300,000 €
- Grants up to 25% of the eligible costs
- Maximum amount of aid for all the hires: 120,000 €
